Know the Symptoms

- Based on cases, administration will work with NH DPHS on action/next steps

Symptoms of COVID-19

- Fever 100.4F or more or chills
- Cough
- Shortness of breath or difficulty breathing
- Sore throat
- Nasal congestion or runny nose
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste/smell
- Nausea or vomiting
- Diarrhea

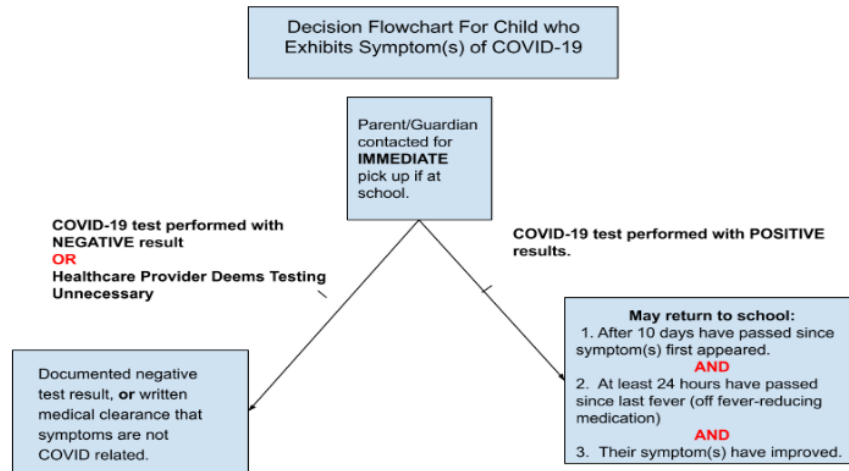
Contact your child's healthcare provider and notify your school nurse.

When do I keep my child home from school?

If my child...

- Has any symptoms, even if mild
- Has had close contact with a person suspected or confirmed to have COVID-19.
- Has traveled outside of NH, VT, ME, MA, CT, or RI in the prior 14 days.

Contact your child's healthcare provider and notify your school nurse.



Responding to Covid-19: Presence of Multiple Cases

- The NH DPHS will be in contact with the school district regarding any positive case.



- If a student or staff member tests positive, the school may be closed for a period of 2-5 days.
 - NH DPHS will gain a better understanding of the situation impacting the school.
 - Clean and disinfect the school.
- Significant outbreak in Auburn or surrounding towns.
 - Work with NH DPHS to determine if it is appropriate to initiate an extended closure.

Health And Safety

Face Coverings

- Required for students in grades 2-8
- Encouraged for students in K-1
- Required on the bus
- Mask breaks will be incorporated into schedule (6ft. distancing)
- Provided by family/Available at school

Social Distancing

- 6' distancing in grades K-1
- 3' distancing in grades 2-8

Cohorts

- Consistent group of students who stay together
- K-4: One classroom all day
- Grs. 5 & 6: One classroom, teachers move to students
- Grs. 7 & 8: Students will change classrooms



Cleaning and Sanitizing

- CDC Guidelines
 - Disinfecting building/facility
- Disinfectant for Use Against SARS-CoV-2 (COVID-19)
- EPA approved



- Daily cleaning and disinfecting is key to maintaining a safe environment.
 - Evening disinfecting will primarily be done with an electrostatic sprayer
- Common area touchpoints will be disinfected throughout the day.
 - Door handles, push bars, light switches, railings, restrooms, etc.
- Hand Sanitizing.
 - Students, faculty, and staff will be required to sanitize their hands as they enter the school or any new location throughout the day

Arrival and Dismissal

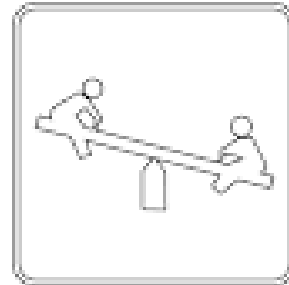
- Routes will be clearly marked to limit two-way traffic and to maintain social distancing during arrival and dismissal.
- Face coverings will be worn during arrival and dismissal.



- Arrival
 - Vehicle: Enter through parent pick-up door and proceed to classroom
 - Bus: Only 2 buses unload at a time. Students proceed to classroom.
 - May pick up breakfast in the café.
- Dismissal
 - Vehicle: Students wait in classroom until parent arrives and is dismissed to appropriate parent pick-up door.
 - Bus: Students wait in classroom until bus is called. Only 2 buses will be called/loaded at a time.

Recess

- Students will have the opportunity to participate in outdoor recess activities.
 - Outdoor space will be divided into quadrants.
 - Students will use the assigned quadrant which will rotate.
- Teachers, with the help of the PE teacher, will assist students in activities that can be played while maintaining social distancing guidelines.
- Students will follow proper hand hygiene practices before and after recess.



Food Service

- All meals will be eaten in the classroom.
 - Exceptions will be made for students with allergies
- Students receiving school lunch will pick up pre-packaged meals in the cafeteria by cohort.

- Students will not share utensils or other items.
- Students will wash hands prior to meals.
- Each table/desk will be cleaned prior to meals being consumed.
